**Effective April 15, 2013** all UKC Litter Registrations, and UKC Permanently Registered dogs with more than one owner will be required to designate a Sole Signatory.

**DEFINITION:** A Sole Signatory is an individual that has been appointed by all registered owners of a specific dog to sign all UKC Registration Documents on their behalf.

**Please note that until your dog is sold to another individual, no action needs to be taken on your part. However upon selling this dog, the new Registrant(s) will be responsible for choosing a Sole Signatory.**
